THE MISSION HAS AN EMERGENCY SHELTER, 12-MONTH RESIDENTIAL LIFE-TRANSFORMATION PROGRAMS, THE FREEDOM ROAD DAY PROGRAM, A PART-TIME MEDICAL CLINIC, TRANSITIONAL HOUSING FOR MEN'S AND WOMEN'S PROGRAM GRADUATES, PERMANENT HOUSING FOR LOW-INCOME SENIOR WOMEN, AND AFTER-SCHOOL PROGRAMS FOR AT-RISK CHILDREN.
